INVESTIGATIONS AND CRIMINAL LAW

Fighting impunity in a borderless world

In January, TRIAL International denounced former Gambian Minister Ousman Sonko for alleged torture. Sonko is detained and under investigation for crimes against humanity. TRIAL International has also joined the international campaign to bring to justice Sonko's superior, the former president of Gambia Yahya Jammeh himself.

In Switzerland, proceedings against Rifaat Al-Assad – the uncle of Syrian President Bashar Al-Assad – are stalling. Suspected of war crimes, he has been under investigation for the last 4 years but no measurable progress has been made. TRIAL International has documented the alleged crimes extensively, hoping the evidence will prompt the authorities into action.



NEPAL

New local structure and reinforced regional reach

Recognizing the need for a stronger in-field presence, TRIAL International established its first permanent structure in Kathmandu. Opened in April, the Human Rights and Justice Centre informs victims on their rights and offers them free legal representation in domestic and international litigation.

TRIAL International has also extended its activities outside of Kathmandu, launching a coaching program for lawyers in Biratnagar (Eastern region) and taking up cases of victims from remote areas.

DEMOCRATIC REPUBLIC OF THE CONGO

Landmark cases rekindle hope despite political crisis

An unprecedented number of mass crimes trials opened in Eastern DRC in 2017. In the province of South Kivu alone, three major trials led to the conviction of a dozen criminals for mass crimes, and victims were awarded significant reparations. TRIAL International has been involved in most trials, coaching lawyers and ensuring victims received holistic support.

Moreover, the organization extended its training programs to new legal actors, including prosecutors, magistrates and activists, seeking to consolidate all judicial functions in Eastern DRC.



BURUNDI

Building local know-how for international litigation

Burundi made the international headlines in November when the International Criminal Court (ICC) announced an investigation into alleged international crimes. This development, along with rampant domestic lawlessness, led TRIAL International to focus on international litigation and to reinforce its training programs on international standards and procedures, with a special focus on the ICC.

Using its insight into the dysfunctional domestic judiciary, TRIAL International was also able to provide first-hand information to the ICC on the difficulties victims faced in obtaining justice and reparation.

BOSNIA AND HERZEGOVINA

Advocacy success for TRIAL International's longest-running program

Accessing reparations remains highly challenging for victims and wide discrepancies persist within the country. TRIAL International focused its advocacy efforts on improving and harmonizing practices, from the inclusion of compensation claims in criminal proceedings, to establishing criteria for adequate awards and enforcing rulings.

Making proceedings safer for vulnerable victims, including before civil courts, has constituted a second axis of advocacy. After a series of successful meetings, TRIAL International worked towards amending the Codes of Civil Procedure.
